# **EAST PARK ACADEMY**

## **COMMUNICATIONS POLICY**

### **Rationale**

Good communication between the school and the home is essential. Children achieve more when schools and parents work together. Parents can help more if they know what the school is trying to achieve, and how they can help.

### **Introduction**

In our school we aim to have clear and effective communications with parents and the wider community. Effective communications enable us to share our aims and values through keeping parents well informed about school life. This reinforces the importance of the role that parents play in supporting the school in educating their children.

We communicate with parents through a range of different strategies. Some of our communications are the result of a statutory requirement, others reflect what we believe is important to our school.

### **Home School Agreement**

Our latest Home School Agreement has been in place since September 2017, which is a statutory requirement. It explains the school's aims and values, the school's responsibilities towards the children, the responsibilities of parents, and what the school expects of the children. We ask parents to sign this agreement when their child starts in our school. This is shared with parents in each child's reading log which they receive in September.

The agreement covers the standard of education in our school, the ethos of the school, our expectations on attendance and good behaviour, and our expectations about homework. Our governing body reviews the agreement annually, and publishes the details of this review in the governors' annual report to parents.

### **Annual written report to parents : children's achievements**

Each year we provide a written report to parents on each child's progress in the various areas of learning of National Curriculum subjects once per term. These are known at East Park as 'Progress Slips'. This report also identifies areas of strength and areas for future development. In our school we ask the children to comment on their own progress, and parents to make a similar comment. We also give children in Year 2 and Year 6 the details of their performance in the national tests, and details of national comparative performance in the national tests. In all year groups we provide end of year forecasts and national curriculum assessment information

As well as receiving their termly 'Progress Slip', parents meet their child's teacher each term for a private consultation. This gives parents the opportunity to celebrate their child's successes and support the child with any areas of development. Parents are able to look at their child's work during these meetings. We encourage parents to contact the school if any issues arise regarding their child's progress or well-being.

## Website and Social Media

The school website: [eastparkacademy.com](http://eastparkacademy.com) contains a range of specified information that gives parents a full picture of provision at our school. We update the website weekly when changes occur during the year. Our Twitter and Facebook accounts have high levels of engagement, allowing parents to be in constant, regular contact with school (@WeAreEastPark / @East Park Primary).

## Public access documents

The school makes available a range of documentation for parents. We keep a master set in the school office, and we make this available on request. It contains copies of all school curriculum policies, minutes of governing body meetings and copies of policies that the governors are required to have in relation to charging and remissions, sex education, health and safety, curriculum, performance management, admissions and action planning following inspection. It also contains a range of national and Local Authority documentation.

## Home-school communications

We send a newsletter to parents every week. It contains general details of school events and activities. Parents expect the newsletter and appreciate the regularity of the contact. We send other letters of a general nature when necessary.

At the beginning of each term all teachers write to the parents of the children in their classes with details of the work to be covered during the forthcoming half-term. We invite parents to support their child's work through a range of suggested activities to be shared with the child at home. We also invite parents to take part in the educational visit that is linked to the work. Targets for Maths, English and Science are also shared with parents each term. These are the targets the child will be focusing on, and the information gives parents and carers suggestions on how they can help their child achieve these targets.

Children in all classes have a Home reading log where weekly reading homework is also communicated to families. This enables parents to record a wide range of information that they share regularly with the teacher. Children and teachers use the Home reading log to record homework assignments, and as a regular channel of communications with parents.

The school encourages parents to share any issues about their child at the earliest opportunity. Teachers see parents immediately, if at all possible. Where this is not possible, the parent makes an appointment. We allow many parents to take the opportunity to have a discussion with the teacher when they bring/collect their child from school.

Parents also have access to a year group email address that is directly linked to each year group leader. The Headteacher's email is also shared with parents.

We arrange many meetings for families in addition to termly parent/ carer progress meetings. These include:

- SEN meetings
- Induction meetings for nursery, reception
- Transition meetings for KS 1 and KS 2
- Residential meetings
- Secondary transfer meetings

- If a child is absent from school, and we have had no indication of the reason, we contact a parent by telephone, if possible, to find out the reason for the absence.
- Pastoral team meetings with 'The Julies'

In order to elicit parent views we are committed to asking families to complete a termly questionnaire that is analysed by the senior leadership team.
